This portfolio, documented in this way, is subject to change according to the various legislations. However, in 2020, it corresponds to the recommendations related to IFSPT, Belgian education degrees and also, to the requirements as they are currently suggested to obtain a QPP in sports physiotherapy.

The constitution of your portfolio is substantial but it already shows your solid commitment in the vast field of physiotherapy that is that of sports physiotherapy.

This Portfolio should allow everyone to evolve at their own pace of training and maintenance of knowledge. Certify Long Life Learning in specific education at an academic level in the different areas of competence of the SPA project (continuing education post-training Sport-Rehabilitation initial specific, supervised internship, publication in the field of sports physiotherapy by reference to SPA project axes ...)

# (General Measure 3)

Attest to a practice of at least 75% of working time in at least one of the SPA project areas of competence. We draw your attention to the fact that you are committing your honor to justify your commitment to this vast area of physiotherapy.

#### (Specific Measure 1)

In case of 300 ECTS:

Diploma or Academic Certificate in Sport Specific Rehabilitation (45 ECTS minimum, including 6 ECTS of internship). These may be included in the 300 ECTS program.

In case of 240 ECTS:

Master II (45 ECTS), Academic Certificate (10 ECTS per Certificat to a total of 45 ECTS)

Sport Specific Doctorate and Sport Specific Rehabilitation (File to be submitted to BFSP on beforehand). Three international publications in the field of specific rehabilitation of the athlete can be considered as fulfilling this criterion (file to be validated by the BFSP board).

# (Specific measure 2)

Attest of participation in:

- 2 national academic and specific sports physiotherapy congresses
- 1 international academic congresses or recognised by BFSP, within the domain of sports physiotherapy.

### or equivalent

The 2 national congresses can be replaced by 1 annual international congress.

# How to complete your Portfolio and how to propose it to BFSP?

For each Measure (General and Specific), it is necessary to :

- Indicate the minimum elements required for each row of the table
- Append behind each page the documents justifying your indications (Diplomas, Certificate, attestation of presence, program, ....)

# **WARNING**

#### For obvious reasons:

- It is imperative that each "Measure" is fully documented, if an element is missing (information in the table or supporting document), the "Measure" cannot be considered.
- To be considered, each training must be directly related to the practice of sports physiotherapy and must be specific to it. It must be provided in a Belgian higher education establishment (University, Haute Ecole) or recognized by ARES. Finally, only training with a successful exam can be considered.
- The indications are comparable for each congress or conference.
